A WORD FROM OUR CEO & FOUNDER, NICOLA ELKINS

2022 was a turbulent year for markets which is often reflected in corresponding dips in donations to the Foundation. However, I am happy to report that despite these uncertainties, Benefaction had a record year with over \$131 million in total donations received. We also had a record \$35 million in grants disbursed at the request of our donors.

In 2022 we introduced a Reciprocity Fund, grants from which are at the discretion of our Board of Directors. This shift was in part due to our membership in <u>The Circle on</u> <u>Philanthropy</u>. You will read more about our 2022 grants later in this report. We intend to expand the focus of the Fund to provide support for other racialized communities and organizations and help to shift the sector's orientation further toward equity and justice.

We also implemented changes in our minimum disbursement quota to meet the CRA's increase to 5%, which took effect on January 1, 2023. At Benefaction, this minimum is applied to each donor advised fund helping to ensure more funds get into the hands of operating charitable organizations quickly and that we continue to make a meaningful difference across the Canadian philanthropic sector.





Donor Advised Funds

In 2022, 169 Funds at Benefaction were funded, bringing our total to over 1,000. This growth occurred despite a challenging year economically, which is evidence of the generosity of our donor community.

This breakdown provides insight into the causes Benefaction donors' support, but it is not fulsome. Grants are often made with specific designations unrelated to sector type. For example, a grant to a community church may be designated to sponsor a food drive or a grant to a University may be designated to support a sports team.

RECIPROCITY FUND

Benefaction, as an organization, also gives back. We have our longstanding Director's and Philanthropy Fund which disbursed \$50,000 to CAGP Foundation in 2022, and \$50,000 to organizations at the Director's discretion. We also launched our **Reciprocity** Fund in an effort to acknowledge the systemic inequalities that pervade our society, including the philanthropic sector. As a settler philanthropic organization, Benefaction established this Fund to support organizations across Canada in the spirit of reciprocity.


